

6.3.3 Examination and Evaluation

Examination and evaluation are done on semester basis. Between each semester one mid semester is internally conducted and calculated. Examination systems are fully computerized and all works are done online. Timely examinations are conducted. Evaluation work is done outside the college and the whole process is confidential. Results of final semester students come on time which is beneficial for the candidates moving outside to pursue higher studies.


